The defendant in the Superior Court of Fulton County, by his answer to the motion for a change of venue filed on his behalf by counsel, admitted that he was a resident of Henry County, Georgia, and further admitted the appointment of the judge of the superior court of that county, charged with the duty of trying the case, that he was duly sworn as a member of the court, and that he had not been properly served or notified of the pendency of this action. This statement of facts then made by the defendant, while in his answer, shows that he was not a resident of the county in which the action was pending, and as a result of this admission by the defendant, under the provisions of law dealing with change of venue, the judge of the superior court of Fulton County, duly appointed by the judge of the superior court of Henry County, so charged with the duty of trying the case, should have granted the motion to change venue to the superior court of Henry County, having venue of the case. While an opposite conclusion has been reached by a majority of the Justices of this court in the case of Beall v. Beall, 86 Ga. App. 719 (72 S. E. 2d 204), a careful examination of that case, together with a review of the other authorities cited by the plaintiff, convinces the writer that it is the correct conclusion reached in the Beall Case, and that any holding to the contrary in the instant
